14 Application for the review of a Premises License

The Corporate Director Environment submitted a report to support the committee in considering an application for review of a premises license, submitted by Lancashire Constabulary under section 51 of the Licensing Act 2003.

The Chair said to the committee that there was an update to the meeting, which he asked the Senior Licensing Officer to introduce. He explained to members that owing to illness, the applicant's representative was unable to attend this meeting, and asked the committee to consider adjourning to a later, specified date in order for the applicant to have their right to be represented at the hearing. The Legal Services Manager echoed the officer's view that, in order to hold a fair hearing, the meeting should be adjourned to another date.

The Chair asked the committee to consider adjourning the meeting. A proposed date of the 30 November, at 6pm was considered. This was **unanimously agreed** by the committee, who resolved to meet to review this application on the 30 November 2022.
