Agreed (by 28 votes to 10, with 2 abstentions) that the minutes of the meeting of the Council held on 14 June 2018 be confirmed as a correct record, subject to "Cllr Bridge" being inserted instead of "Cllr Berry", as the responder to a question from Cllr Fail in the first line of the second paragraph in minute 15(3).

22 Declarations of Interest

23 Announcements

- 1. The Chief Executive advised that any Councillors who were also members of Lancashire County Council should only speak or vote on the Notice of Motion to be considered under agenda item 11 if they made it clear that, even if they had participated in the debate on a similar motion approved by LCC, they were nevertheless prepared to consider the motion with an open mind at this meeting. Councillors A Vincent, Beavers and Kay indicated that they were able to give such an assurance.
- 2. The Mayor announced that she, the Deputy Mayor and Cllr E Anderton would be doing a sponsored parachute jump on Sunday 2 September, with all proceeds going to the Mayor's charities.
- The Mayor announced that she had been informed that Councillor Emma Anderton has been elected as Deputy Leader of the Labour Group.

26 Executive reports

(c) Street Scene, Parks and Open Spaces Portfolio Holder

The Street Scene, Parks and Open Spaces Portfolio Holder (Cllr Bridge) submitted a report.

Cllr Bridge, when introducing his report, referred to the four parks in the Borough which had been awarded Green Flag status and welcomed the recent award of Heritage Lottery Grant funding for the refurbishment of the Mount Pavilion and Gardens at Fleetwood.

Cllr Bridge responded to questions and comments from Cllr E Anderton about Tram Sunday and Fleetwood in Bloom, from Cllr R Duffy about Memorial Park Fun Day, Cllr Lady Atkins about Garstang Ice Cream Festival and Cllr Beavers about vandalism in parks and gardens.

Agreed that the report be noted.

(d) Planning and Economic Development Portfolio Holder

The Planning and Economic Development Portfolio Holder (Cllr Michael Vincent) submitted a report. He also referred, when introducing his report, to the interim report of the Inspector, following the Local Plan examination hearings held in May, which had now been made available to all councilors.

Cllr Michael Vincent responded to questions and comments from Cllr Fail and Cllr Lees about sports pitches in Bourne Ward.

Agreed that the report be noted.

(e) Neighbourhood Services and Community Safety Portfolio Holder

The Neighbourhood Services and Community Safety Portfolio Holder (Cllr Berry) submitted a report.

Cllr Berry responded to a question from Cllr Lees about cycling on the promenade.

Agreed that the report be noted.

(f) Leisure, Health and Community Engagement Portfolio Holder

In the absence of the Leisure, Health and Community Engagement Portfolio Holder (Cllr Bowen), Cllr Henderson introduced the report.

Cllr Henderson responded to questions and comments from Cllr E Anderton about noise nuisance, from Cllr R Duffy about the comments in the report anticipating events at Tram Sunday and from Cllr Lees about summer events at bandstands.

Cllr Henderson also said he would arrange for a written response to be sent to Cllr E Anderton about the advice to be given to residents about the use of the recently launched noise monitoring app, particularly those who were not proficient in the use of smart phones or did not have access to one.

Agreed that the report noted.

27 Membership of Committees

The Leader of the Council (Cllr Henderson) and the Chief Executive submitted a report on changes required to the membership of committee for the remainder of the 2018/19 Municipal Year, to reflect a change to the political balance of the Council following the resignation of Cllr I Duffy and Cllr R Duffy from the Labour Group. Cllr Henderson proposed the recommendations in the report and also proposed that, in order to implement those recommendations, additional Conservative members be appointed to committees, as follows:

Planning Committee: Cllr CatterallLicensing Committee: Cllr S Turner

Employment and Appeals: Cllr Lady Atkins

Standards Committee: Cllr Orme.

The proposals were seconded by Cllr A Vincent.

Cllr Fail proposed and Cllr E Anderton seconded an amendment to change the method of calculating political balance and allocating places on committees, as set out in the Appendix 1 to these minutes.

A recorded vote on the amendment was requested by four councillors, in accordance with Procedure Rule 19.4. Members voted as follows:

<u>For the amendment:</u> Councillors E Anderton, M Anderton, Barrowclough, Beavers, Lees, Raynor, Robinson, Shewan, Smith, B Stephenson and E Stephenson.

<u>Against the amendment:</u> Councillors I Amos, R Amos, Lady Atkins, Ballard, Berry, B Birch, C Birch, Bridge, Cartridge, Catterall, Collinson, Ellison, Greenhough, Henderson, Hodgkinson, Holden, Ibison, Ingham, Jones, Kay, Murphy, Orme, Ormrod, Pimbley, Robinson, A Turner, A Vincent, Matthew Vincent, Michael Vincent and Walmsley.

Abstentions: Councillor R Duffy.

The amendment was therefore **lost** (by 11 votes to 30, with 1 abstention).

The Chief Executive informed Council that, if the nominations to specific committees proposed by Cllr Henderson were approved, no changes would be needed to the membership of the Audit Committee.

Following further debate on the recommendations in the report a recorded

vote was requested. Members voted as follows:

<u>Against the recommendations:</u> Councillors E Anderton, Barrowclough, Beavers, Lees, Raynor, Robinson, Shewan, Smith, B Stephenson and E Stephenson.

<u>Abstentions:</u> Councillor M Anderton and R Duffy. (Cllr Holden was not present when the vote was taken).

The recommendations were therefore approved (by 29 votes to 10, with 2 abstentions).

Cllr Fail then reported the consequential changes to Labour membership required to implement the approved recommendations and it was **agreed** that:

- 1. That Cllr I Duffy be removed from the Employment and Appeals Committee.
- 2. That Cllr R Duffy be removed from both the Employment and Appeals Committee and the Standards Committee.
- 3. That Cllr B Stephenson be appointed to the Employment and Appeals Committee.
- 4. That Cllr Catterall be appointed to the Planning Committee, Cllr S Turner be appointed to the Licensing Committee, Cllr Lady Atkins be appointed to the Employment and Appeals Committee, and that Cllr Orme be appointed to the Standards Committee.
- 5. That Cllr E Stephenson be removed from the Planning Committee and Cllr B Stephenson be removed from the Licensing Committee.
- That it be noted that, as a consequence of the appointments to Committees set out above, no changes were required to the membership of the Audit Committee.
- 7. That Cllr E Stephenson be appointed to the Overview and Scrutiny Committee in place of Cllr E Anderton.

28 Citizens Advice Lancashire West: Replacement Representative

The Leader of the Council (Cllr Henderson) and the Chief Executive submitted a report on a proposed change to the Council's representation on Citizen's Advice Lancashire West.

Agreed (by 30 votes to 0, with 9 abstentions) that Cllr Cartridge be appointed as the Council's representative on the Board of Citizens Advice Lancashire West.

29 Social Media Policy for Councillors

The Leader of the Council (Cllr Henderson) and the Monitoring Officer submitted a report on a proposed social media policy for councillors.

Agreed (by 28 votes to 11) that the Social Media Policy for Councillors, attached as Appendix 1 of the report, be approved and included in Part 5 of the Constitution.

30 Notices of Motion

The following motion (which had been submitted under Procedure Rule 14 by Councillors Henderson, A Vincent, Bridge and Michael Vincent) was formally proposed by Cllr Henderson and seconded by Cllr A Vincent.

"Lancashire Combined Fire and Rescue Authority remains committed to delivering the best possible service to its communities, with the resources it has available. It continues to work productively and effectively with a range of stakeholders. The new statutory duty to collaborate with other emergency services is also acknowledged, while recognising many initiatives were already in place or in development irrespective of this mandate.

The Fire and Rescue Authority remains confident that current governance arrangements present the best way to deliver a fire and rescue service for its communities. It will though provide the information required for the work proposed by the Police and Crime Commissioner (PCC), which it believes will evidence that it is already effectively progressing collaborative opportunities within existing structures.

Consequently, this Council places on record its opposition to any proposals that transfer any current responsibilities of the Fire and Rescue Authority in Lancashire to the Police and Crime Commissioner.

Wyre Council therefore asks the Chief Executive to write to the Police and Crime Commissioner and the Home Secretary explaining this view, sending copies to all Lancashire Members of Parliament."

Agreed, following a debate that the motion be approved (by 29 votes to 0 with 11 abstentions).

1. Total Proportion of Members

NB Percentages are imprecise – percentages would be okay if dealing with all 50 members, but not 47 members (unless rounding is dispensed with)

There are a total of 80 seats on the Committees to which the Political Balance Calculations apply.

Comments/Proposals

As well as the whole seats allocated above, both the Conservative and Labour Groups will need to be allocated an additional seat on each of 4 committees to achieve the required total allocation of 61 seats and 19 seats respectively.

As the rule at 5.1a) of the report must apply, Labour must be given a place on each of the Senior Officer Committees. Para 3.2d of the main report details how the remaining 6 places should be allocated.

Amended Paras Within Item 8

- 3. Recommendations
- 3.1 That, in order to achieve political balance on the Committees appointed by the Council, 61 seats on those committees be allocated to members of the Conservative Group, 19 seats be allocated to members of the Labour Group and that no seats be allocated to the three non-aligned independent councillors, with seats on each individual committee apportioned on the basis set out in Appendix 1.
- 3.2 That in order to implement the recommendation in 3.1, the following changes be approved:
- (a) That Cllr I Duffy be removed from the Employment and Appeals Committee.
- (b) That Cllr R Duffy be removed from both the Employment and Appeals Committee and the Standards Committee.
- (c) That a Labour member be appointed to the Employment and Appeals Committee.
- (d) That an additional Conservative or Labour member be appointed to all six of the following committees: -
 - Overview & Scrutiny Committee
 - Planning Committee
 - Licensing Committee
 - Audit Committee
 - Employment and Appeals Committee
 - Standards Committee.

The Party having the most unallocated seats chooses the Committees until the shortfalls of each Party are level. Once level the other Party then has the next choice, with the following choices then alternating between the parties, ie. as the Conservatives have 4 unallocated seats, and Labour have 2 unallocated seats at the outset, the choice of committees will be:-

1st Choice - Conservative

2nd Choice - Conservative

3rd Choice - Labour

4th Choice - Conservative

5th Choice - Labour

6th Choice - Conservative

5.4 The application of the calculations to allocate the 80 seats available on the Committees appointed by the Council to which these rules apply, is shown in Appendix 1. The outcome is a total allocation of 61 seats to the Conservative Group and a total allocation of 19 seats to the Labour Group.

Executive Report: Leader of the Council

1. Purpose of report

1.1 To inform Council of progress on key objectives and the current position on a number of issues, as set out below.

2. Blackpool, Fylde & Wyre Economic Prosperity Board

- 2.1 On the 17 July the second meeting of the Blackpool, Fylde & Wyre Economic Prosperity Board (EPB) took place at the Lancashire Energy School (Blackpool & The Fylde College) located within the Blackpool Enterprise Zone and in the absence of Cllr Simon Blackburn I chaired the meeting.
- 2.2 We received a presentation from Nigel Wilcock of Mickledore about the findings of a Business Investment Marketing Perceptions Study and of particular interest was the above average attainment levels of students studying A levels or equivalent and the need to create job opportunities on the Fylde Coast to retain young local talent.
- **2.3** We agreed the following four priorities:

Housing Growth and Quality of Life

Improve the quality of rented housing through new potential flexibilities from Government via the ability to vary Housing Benefit / Local Housing Allowance rates. Include housing growth in the urban areas and on difficult sites, incorporating affordable energy costs, access to health and community provision to establish a destination with a 'sense of place'

Connectivity

Develop physical infrastructure, strategic partnerships and digital networks that support growth within and around the Fylde Coast. Connectivity on a Lancashire and North West footprint through the promotion of skills, accessibility and technological provision in comparison to the offer of others. Strengthening partnerships at the regional level to drive forward opportunities developing higher skills in specialist sectors not necessarily within the Fylde Coast.

Accelerated Growth focusing on our Enterprise Zones

Ensure the successful delivery of the Enterprise Zones and identify the skills needed to support meaningful growth for businesses and individuals. Identify and develop supply chain networks via partnerships and educational institutions with particular focus on Research and Development opportunities across Lancashire and the North West. Development to establish best practice, accessibility and promotion of continuing business support initiatives to provide longevity to harness businesses growth aspirations.

Marketing

Ensure effective marketing as a business investment location to complement the tourism marketing offer at a local/sub-regional/national/international level. Focusing on priority sectors and working with Marketing Lancashire to ensure effective coordination and integration with the Lancashire offer.

3. Lancashire District and Lancashire Leaders and Chief Executives Meetings

3.1 On the 24 July Lancashire District Leaders met in the morning followed by an afternoon meeting of Lancashire Leaders and Chief Executives.

Lancashire District Leaders:

- 3.2 It was agreed that Cllr Matthew Brown, Preston City Council, be appointed to the Lancashire Local Economic Partnership Performance Committee.
- 3.3 The Chair and Chief Executive of the Fire Authority gave an excellent presentation including clear, compelling and well evidenced reasons as to why the Police and Fire Service should remain independent organisations. There was unanimous support amongst Lancashire District Leaders that the Fire Authority and Police Service should remain independent organisations.

3.4 Lancashire Leaders and Chief Executives Meetings:

At this meeting we had a presentation from Professor Sue Smith and her colleagues from UCLAN on the Lancashire Economic Picture and Productivity Analysis but the main focus of the meeting was a discussion on the economic and growth priorities for Lancashire that would form the basis for a refresh of the Strategic Economic Plan (SEP) and I put forward the four high level strategic priorities agreed at the EPB meeting.

- 3.5 In addition Cllr Simon Blackburn gave an update on the proposal by the Police and Crime Commissioner to take control of the Fire Service and we also discussed the merits and opportunities of a Community Bank.
- 3.6 We also agreed work themes and I, along with the Leaders of South Ribble and West Lancashire, (with support from David Welsby CEO

Hyndburn) have agreed to develop a work programme for Environment/Climate Change which will cover the following:

- Air quality
- Green spaces
- Waste and future recycling
- Clean energy
- Flood alleviation and prevention
- 3.7 Cllr Simon Blackburn along with the Leaders of Lancaster and Ribble Valley (with support from our CEO Garry Payne) have agreed to develop a work programme for Housing which will include the following:
 - Quality, affordability and choice
 - Housing benefit
 - Relationship with Homes England
 - Housing growth

4. Other Activities

- 4.1 On the 19 July the Chief Executive and I attended a meeting a Flakefleet Primary School. The meeting had been arranged by Regenda to develop closer working relationships with the Regenda Group, schools and other Partners but the main focus and purpose was around raising young people's aspirations.
- 4.2 Ward Members, as representatives of their communities, can play a key role in helping to raise the aspirations of young people and the Regenda Group are focusing their attention on the area of Fleetwood. I have suggested to Steve Newsham (Regional Director Lancashire, Regenda Homes) that he should contact Ward Members in Fleetwood for their support and I am sure that those Ward Members will relish the opportunity to actively engage in this project.
- 4.3 On 25 July Cllr Berry and I attended a verification meeting of the Police and Crime Panel. The purpose of the meeting was to verify the Police and Crime Commissioner's (PCC) proposal to establish the post of Deputy PCC. Whist the Panel's decision was not to support the proposal, on the 26 July the PCC went ahead and advertised the role, a decision which, in my opinion, makes a mockery of the Panel verification process.

Executive Report: Resources Portfolio Holder

1. Purpose of report

1.1 To inform Council of progress on key objectives and the current position on issues within the Resources Portfolio, as set out below.

2. Finance

- 2.1 I am pleased to report that the authority's 2017/18 Statement of Accounts received an unqualified audit opinion. The External Auditors Report to those charged with governance, which was considered by the Audit Committee on 24 July, also recognised that the authority's Value for Money arrangements ensure that the authority had proper arrangements to ensure it took "properly informed decisions and deployed resources to achieve planned and sustainable outcomes for taxpayers and local people".
- 2.2 At the meeting I understand that Amanda Latham (a Director at KPMG) commented that the result reflected the level of detail, robustness and quality of the working papers which is a testament to the professionalism of the team and to be commended. Ms Latham said that few authorities in their experience had been able to meet the new statutory deadlines without making errors and Wyre were one of a small number to achieve this. She went on to thank the Financial Services Team for their cooperation throughout the audit and their teamwork approach to what is an intensive three to four weeks. I would like to extend my thanks to all the staff who were involved in the production of the Accounts and to the Audit Committee for overseeing what is a very complex and important document.

3. Contact Centre

3.1 The roll-out of the Universal Credit Full Service (UC) commenced in Wyre on 28 July 2018 when Preston postcode addresses were included in the scheme. Going forward, with few exceptions, working-age residents living in rented PR postcode addresses in Wyre and wanting to claim financial assistance to help pay their rent will no longer be able to apply for Housing Benefit (HB), but instead they will have to apply for UC. In addition, those

tenants who are already in receipt of HB will be required to instead claim UC if they have a change in their circumstances that prompts the closure of their current HB claim. UC will be rolled-out to FY postcode addresses from 6 December 2018. In anticipation of this, the DWP have arranged a meeting at Blackpool Winter Gardens on 13 September 2018 for Fylde Coast private landlords. Pension-age HB claimants are unaffected by the roll-out of UC.

4. Asset Management

- 4.1 The previous tenants have vacated the Bungalow, the detached building at the side of the Civic Centre, so this building is now being actively marketed to try and find a suitable new tenant.
- 4.2 Work is due to commence in September on the Civic Centre to relocate the ICT team from the ground floor to the vacant space on the first floor above the doctor's surgery. This move will free up accommodation near to the CCTV control room and discussions are well underway to facilitate the Police and Early Action Team to utilise this space.

Executive Report: Street Scene, Parks and Open Spaces Portfolio Holder

1. Purpose of report

1.1 To inform council of progress on key objectives and the current position on issues within the Street Scene, Parks and Open Spaces Portfolio as set out below.

2. Parks and open spaces

- 2.1 A pre-start meeting about the restoration of the Mount has taken place with the Heritage Lottery Fund and officers working with Ryder Landscape Consultants to prepare the tender for the restoration work.
- 2.2 Work to construct the trail at King George's Playing Field in Thornton is progressing well and there are plans to undertake planting work and the creation of a woodland walk this autumn and winter.
- 2.3 Judging for Britain in Bloom took place across the borough in July and many of our parks and open spaces were featured along the routes. Our Bloomers volunteer a huge amount of time each year and I wish them every success at the awards later this year.
- 2.4 Improvement work has been undertaken at the Wyre Estuary Country Park by volunteer work parties to improve the footpath from the main car park to the play areas and the paths to the grasslands and woodlands.
- 2.5 The Wyre Estuary Country Park held its annual Open Day with Homeless Hounds and it was deemed a great success by all with dog friendly and family friendly activities taking place showcasing the park as great place to visit.

3. Waste and recycling

3.1 The performance of the waste and recycling service remains at an extremely high standard with service related complaints kept to a minimum. I'd personally like to thank the operational crews who have worked in some extremely hot conditions this summer, especially considering collection crew operatives walk on average 8-10 miles per day.

- **3.2** Officers are working with Veolia on the Annual Service leaflet and calendar that will be distributed in late November / early December.
- 3.3 Subscriptions for the green waste service continue to be received, with the take up matching that of previous years.

4. Street scene

Executive Report: Planning and Economic Development Portfolio Holder

1. Purpose of report

1.1 To inform Council of progress on key objectives and the current position on issues within the Planning and Economic Development Portfolio, as set out below.

2. Coastal Community Teams

Cleveleys

- 2.1 An annual 'Big Cleveleys Clean Up' took place on 7 August in the town centre, which was a great success.
- 2.2 Dobbies Garden Centre have donated a substantial amount of plants to fill up the huge planters in the town centre to last throughout the summer.
- 2.3 Engineering company WEC have manufactured a community notice board for the team to display community information and activities. Painted in a matching green to complement the new bollards it will be situated in a busy pedestrian thoroughfare in the town centre and will be installed by late summer.
- 2.4 Blackpool and The Fylde College art students have designed the concept for a map to be installed at Cleveleys Bus Station. The concept is now being brought to life by a local graphic designer and will be installed by late summer. Deep cleaning of the walls and floor of the station has now taken place and also the lettering in preparation for the re-painting of the bus station, which will take place over the summer.
- 2.5 The paintwork on the clock shelter has been stripped off and HMP Kirkham will be re-painting it this summer with heritage colours to match the rest of the painting works taking place in the town centre.

2.6 I am pleased to confirm that a pilot weekly market in Cleveleys on a Wednesday. The trial market will take place at the Plaza at the end of the summer and has received much support from retailers, residents and other market traders.

3. Hillhouse Enterprise Zone (EZ)

- **3.1** Progress is continuing on the Masterplan with How Planning appointed to complete the Planning Policy element of the document. A final draft of the full document has been submitted and we will soon be commencing a six week statutory public consultation.
- **3.2** Ground surveys at three sites at Hillhouse are taking place in preparation to install the new signage and advertisement consent will be sought before installation.

4. Business support

- 4.1 A Wyred Up Steering Group is currently being established. It will be made up of representatives who are experts in their fields and will drive forward the new priorities for Wyred Up, supported by an action plan.
- 4.2 The next Wyred Up event will take place on 27 September at the Marine Hall, Fleetwood. This event will be the first 'Accelerating Wyre' event pulling together local partners and support services to enable businesses to access support in one place. There will be seminars and workshops throughout the day. Confirmed partners include, Boost Business Lancashire, Positive Footprints, UCLAN, Lancaster University and The Growing Hub.
- 4.3 In October we will hold 'Building Wyre', which will provide a one stop shop for all potential and existing contractors, to help raise awareness of the opportunities the current housing activity bring.
- 4.4 To enable us to keep Wyred Up members well informed we have established a monthly newsletter. They will receive up to date information on local issues as well as support available at a Lancashire level.
- 4.5 We are currently developing a Wyre Business Survey. This exercise has not been undertaken before. The results of this survey will help inform the priorities of our Economic Development Strategy and give us a valuable insight into the needs and wants of our business community. It will also enable us to strengthen our relationship with the private sector by engaging with them on local and regional issues, potential barriers to growth and business support.

5. Planning policy

Local Plan

5.1 Following the closure of the hearing sessions of the examination into the soundness of the Local Plan on 5 June, the Inspector's Post Hearing Advice note to the council was received early in July and the response to this was published on 30 July. The Policy Team is now preparing a consolidated

schedule of Additional Main Modifications and Main Modifications in accordance with the Inspector's advice and requirements which will be subject to a sustainability appraisal. The council's response to the Inspector's Post Hearing Advice note and the Schedule of Main Modifications together with an Addendum to the Sustainability Appraisal Report are being considered separately at this meeting. Subject to approval, the Schedule of Main Modifications and the Addendum to the Sustainability Report will be subject to public consultation for six weeks later this month.

5.2 Following the consultation we will summarise and be responding to the representations and both the representations and our responses will go to the Local Plan Inspector, who will decide whether or not any of the issues raised requires a new hearing. If not, the Inspector will consider the representations before issuing his final report which, without any additional hearings, would be expected to be sent to us in December.

6. National Planning Policy Framework (NPPF) 2018

- 6.1 The NPPF originally published in March 2012, has now been replaced by a new version published on 24 July 2018. Whilst there is some difference to the approach to some key policies, this does not affect the emerging Local Plan. The revision has not simply affected the content of the NPPF but also its structure; the document is now set in 17 topic-based chapters which provide a clear overview of the planning framework and the relevance of different policies.
- 6.2 The order of the chapters also better reflects the new priorities of the Government, now very much focused on delivering solutions for housing through the plan-led system. The NPPF review is mostly focused on housing, particularly on ways for improving delivery to reach the 300,000 homes per year target (nationally) and how to increase affordable housing provision. In particular the new NPPF introduces a standardised methodology for calculating local housing need and introduces a housing delivery test which requires the required rate of housebuilding to be maintained throughout the plan period with the 'presumption in favour of development' being introduced where the rate falls below the identified target (measured over three years).
- 6.3 The new NPPF also recognises the rapid changes that are affecting the retail sector and, as a consequence, it recognises that diversification is key to the long-term vitality and viability of town centres, to 'respond to rapid changes in the retail and leisure industries'.

Executive Report: Neighbourhood Services and Community Safety Portfolio Holder

1. Purpose of report

1.1 To inform council of progress on key objectives and the current position on issues within the Neighbourhood Services and Community Safety Portfolio as set out below.

2. Community Safety

Funding bid to support the victims of domestic violence

- 2.1 Almost £19 million of funding to expand support for survivors of domestic abuse services across England was launched in July by the Secretary of State for Communities. Councils working in partnership with charities and other organisations are able to bid for a share of funding to support survivors of domestic abuse. Funding is available for a wide range of services to help survivors rebuild their lives; including the provision of refuge beds, education, and employment and life skills training. This funding builds on £20 million allocated in 2016 to 2018 which has helped provide more than 2,200 new bed spaces in refuges and other specialist accommodation, supporting more than 19,000 survivors with a safe space to rebuild their lives.
- 2.2 A joint bid is being pulled together between Blackpool, Fylde and Wyre Councils with the priority for Wyre being the continuation of support to Fylde Coast Women's Aid to provide counselling resources and extra refuge hours to enable the refuge to support complex needs victims. In addition the bid will request additional funding for a Children and Family Safeguarding Worker to be based within the refuge to work with eligible victims both within the refuge and in the wider community.

Police and Crime Panel for Lancashire

- 2.3 In his report at a recent meeting of the Police and Crime Panel for Lancashire the Police and Crime Commissioner indicated that the All Crime figure for Lancashire has increased by 18% over the last 12 months which is above the national figure of 13% but below the NW region figure of 23%. Some of this increase is attributable to increased crime reporting but there have been increases in non-injury assaults, less serious injury assaults, harassment and public order offences. Domestic abuse crime continues to increase but Anti-Social Behaviour is down. These trends are also evident in Wyre.
- 2.4 HM Inspector of Constabulary have carried out an inspection report on vulnerability (mental health and domestic abuse) and strategic capabilities and rated the Lancashire Force with an overall grade of good.
- 2.5 The Commissioner has promised to present to the Panel reports on the management of the policing of the Fylde fracking site, victim user satisfaction rates with the Police (which are decreasing) and the HM Inspector of Constabulary's Inspection Report on child protection where significant improvements have been made to address earlier adverse comments.
- 2.6 The Panel unanimously rejected the Commissioners justification to appoint a deputy, which is a political appointment. They did not consider such an appointment was appropriate at this time especially in the climate of pressures on policing in Lancashire. Despite this the Commissioner has indicated he will still go ahead with the appointment. The successful candidate will be subject to a confirmation hearing before the Panel.
- 2.7 A draft business plan was presented to the Panel on behalf of the Commissioner relating to options for future police and fire service governance in Lancashire. On hearing the views of the Panel the Commissioner indicated that in his talks with Lancashire Fire and Rescue he would now concentrate on ways the two services could collaborate together rather than issues of governance.

3. Private Sector Housing

Licensing of Houses in Multiple Occupation - update

- 3.1 Following recent changes to legislation regarding the licensing of Houses in Multiple Occupation (HMO), mandatory HMO licensing has been extended to include properties of one and two stories; previously properties were only licensable if they were three stories or more. Relevant properties need to apply for a licence from 1 October 2018.
- 3.2 In preparation for this implementation date the Housing Team was written to over 30 local letting agents and over 40 known landlords to advise them of these changes and to identify any properties that will require a licence from October 2018. A database is being collated of all additional properties that require licensing to ensure an efficient transition when the new arrangements begin.

4. Wyre Beach Management

- **4.1** Approval has been given to undertake studies to the value of £412,000 to develop a business case for the first phase of the proposed beach management scheme between the Cleveleys boundary and Fleetwood Ferry Dock. The studies will:
 - provide an understanding of the existing ground conditions
 - identify any environmental constraints and opportunities.
 - update existing bathymetric (the shape and profile of the seabed) and sediment modelling.
 - review and update coastal process information.
 - determine the shoreline evolution over a period of 30 years and to determine the associated wave and tide conditions.
 - determine a sediment budget along the frontage over the next 30 years. The latest anticipated sea level rise will be taken into account.
- 4.2 The studies will be supplemented by additional monitoring data including Radar data capture and the development of a community based consultation and evidence platform.
- 4.3 The approved 2013 Wyre Urban Core Strategy estimates the first phase of works at £22 million and identifies over 11,000 properties reliant on the beach defences to sustain their level of protection. The Strategy recommends that the best value for money option is concrete repairs to the promenade, seawall and revetments with beach management (groynes and recharge). Funding opportunities towards improvements to the promenade open space will also be sought but it should be recognised that Flood Defence Grant in Aid (FDGiA) is directed at protection to properties only.

Executive Report: Leisure, Health and Community Engagement Portfolio Holder

1. Purpose of report

1.1 To inform Council of progress on key objectives and the current position on issues within the Leisure, Health and Community Engagement Portfolio, as set out below.

2. Sport and Physical Activity

Parkour

2.1 Wyre Council, in partnership with Active Lancashire launched a 10 week pilot project on 4 July to offer parkour sessions at Memorial Park, Fleetwood. The sessions held at Memorial Park are aimed at 14-19 year olds and take place every Wednesday evening from 6pm - 8pm. The aim is to reduce antisocial behaviour whilst encouraging young people to become active. The numbers attending the session have been reaching approximately 24 each week with regular attendees and is proving to be a popular activity. The pilot is proving a success and will hopefully be continued after September.

Fleetwood Promenade Park Run

2.2 Wyre Council Sports Development have been the lead organisation in the creation of Fleetwood Promenade Parkrun which was successfully launched on August 4th. The project has taken over a year to recruit, train and develop a core team of over ten volunteers so that they have the right skills in order to run a parkrun event. At the first park run on the 4th August, there were 158 runners and 14 volunteers, which is a fantastic start. Fleetwood Promenade Parkrun is a free weekly timed 5k run or walk starting from Fleetwood YMCA every Saturday morning at 9am. The project will contribute to improving fitness levels, mental health, confidence and quality of life.

3. Arts, Events and Volunteering

Siren's Song

3.1 To celebrate the Wyre coastline a music event took place on Saturday 4 August featuring one man bands, boom bikes and a programme of young performers. A development leading from this event will be further work with UpBeat Academy based in Poulton over the summer of 2019 to produce a programme for young bands, culminating in three or four separate events in Marine Gardens.

Volunteering

3.2 The Wyre Council volunteer programme continues to go from strength to strength, with 228 volunteers and the number of volunteer hours at an all-time high of 8,817 hours donated between April – June 2018.

Just Reminiscing

- 3.3 A review of the eight week drop-in reminiscence sessions at Fleetwood Market took place in July. The project was deemed a success by the volunteers and participants. During this period rapport was built up with local visitors, of whom some brought in their own artefacts and replicas to add to the collection. The time spent talking with people increased, and some really interesting anecdotes were collected. There were approximately 400 visits to the sessions, a mix of local residents and holidaymakers. Sessions will resume at the market on 21st September.
- 3.4 Planning is underway to roll out Just Reminiscing to other parts of Wyre including in Garstang with the Garstang Medical Practice Patient Participation Steering Group, in Hambleton through a local friends group and in Knott End working with the memory café. It is hoped sessions in these areas will start mid-autumn.

4. Community Engagement

- 4.1 We are continuing to promote the FYi Directory to raise the profile of this valuable local resource. This month we visited the Garstang Medical Centre and the Garstang Tourist Information Centre to raise awareness of the directory with patients and residents and how people can access information regarding health and wellbeing in their area. There were also visits to the Patient Participation Group at Garstang, with visits also planned for Great Eccleston and Over Wyre in September.
- 4.2 Over the summer The National Citizen Service for 15-17 year olds has been active in Wyre with over 200 young people taking part in social action projects and challenges. The Community Engagement Team have been actively supporting the development of this programme with event support and with an officer attending the Dragon's Den element of the challenge.
- 4.3 The Council's tourism website www.discoverwyre.co.uk is performing well in 2018 with unique visitor numbers growing significantly from 14,196 between January to May 2017 to 22,359 between January to May 2018.

5. Marine Hall and Thornton Little Theatre

- 5.1 The Harmony and Health sessions at Marine Hall have now grown to a size where we may need to consider moving the group into the main auditorium, subject to availability around other events. Numbers attending the singing sessions at Thornton Little Theatre are also up with over 50+ attendees recently. Harmony and Health in Hambleton is underway and growing with 20+ attendees and further singing groups are being explored elsewhere Over Wyre.
- 5.2 Wyre Theatres continue to work closely with Healthier Fleetwood. At the end of July, Healthier Fleetwood held a showcase dance event 'Fleetwood Loves Dancing' at Marine Hall. This free event aimed to showcase a wide range of dance available to enjoy, either as a means of socialising with others and/or to improve levels of activity. This was well attended, everyone enjoyed themselves and we had great feedback.
- 5.3 At the end of July, The British Dance Championships were held at Marine Hall. This was a week long, high profile event that brought large numbers of people into the area from across the country generating income for the venue and the local economy. After a number of highly successful events, the organiser has committed to extending the hire period by another few days and hiring the venue for another three years.
- 5.4 This year's Heritage Open Days will be on Thursday 13 to Sunday 16 September 2018. Members of the public are encouraged to come along to Marine Hall and other participating venues to find out more about the historic buildings.

Planning Committee: Periodic Report

1. Purpose of report

1.1 To enable myself as Chairman of Planning Committee to inform the Council of the current position on issues being dealt with by the Planning Committee.

2. Scheme of Delegation

2.1 The scheme of delegation set out in the council's Constitution allows for the Head of Planning Services to determine all planning applications. However, that delegation is conditioned by paragraph 1. This allowed for any Member to call a planning application to Committee for determination. To do so, the member must make the request in writing within ten working days of the date of distribution of the weekly list of planning applications, upon which the planning application in question appeared. Members should be aware that all such requests are public documents and will form part of the application file.

3. Applications Determined by the Planning Committee

- 3.1 Whilst most planning applications are decided under the delegated powers, applications of most strategic or local significance or which are or most likely to be controversial are brought to the Planning Committee for a decision as well as those which have been subject to a request in accordance with the Council's Scheme of Delegation. Over the year from 1 April 2017 to 31 March 2018, 99% of all applications have been decided under delegated powers. Looking at individual months throughout the period the figure has varied between 96% and 100%.
- **3.2** Between 1 April 2017 and 31 March 2018, a total of 1239 applications of all types were received and 1119 applications determined. 77 applications were withdrawn. The Planning Committee have considered 22 planning applications.
- **3.3** Of the 22 applications considered by the Planning Committee, 18 (81%) were subject to a member request under the provisions of the Scheme of Delegation, although it is considered that 11 of these would have been

brought to the Committee in any event due to their strategic nature or by reason of their planning history. Two applications were brought to Committee because the applicant was a senior officer of the council or a councillor. Of all applications determined by the Planning Committee, 16 were granted planning permission and six were refused (or minded to refuse). Four (18%) were decided contrary to the recommendation of the Head of Planning Services. Of these, one was granted planning permission contrary to the recommendation and three were refused contrary to recommendation.

4. Appeals

4.1 Between 1 April 2017 and 31 March 2018, a total of 27 appeals were lodged and 26 appeals decided. 40% of appeals on major applications and 33% of appeals on other applications have been allowed. From 1 April 2017 to the present date two out of four appeals relating to applications refused (or minded to be refused) contrary to officer recommendation have been allowed, one was withdrawn, and one was dismissed. The appeal withdrawn related to 16/00407/OUTMAJ - Fleetwood Pier - Outline application for the erection of 15 apartments for persons aged 55 and over together with retail unit and car parking. Those allowed include 16/00650/OUTMAJ - Land off Copp Lane, Great Eccleston - outline application for up to 93 dwellings, and 17/00745/FULMAJ - Land off Laidleys Walk, Fleetwood - Erection of a three storey residential care home for use within Use Class C2. This appeal was against non-determination although the Planning Committee were minded to refuse planning permission. The appeal dismissed related to 17/00069/FUL - Part retrospective application for the erection of a detached dwelling (Resubmission of 16/00356/FUL), rear of former Saracens Head Hotel, 200 Park Lane, Preesall.

5 Other Matters for Information

Member Training

- 5.1 During the year the Planning Committee (and other councilors) have had two externally provided training courses on planning matters. The first, provided by training consultants appointed by the Planning Advisory Service (PAS) was on Tuesday 16 May 2017, and the subject was 'Making Defensible Decisions'. The second event was provided by specialist planning training consultants Trevor Roberts Associates on 14 March 2018 and was on 'The role of Councillors in planning: Propriety and Good Practice'.

 - Internal Audit and Risk Management Progress Report
 - Annual Review of the Audit Committee's Performance
 - Annual Review of the Council's Counter Fraud Polices Anti Fraud, Corruption and Bribery, Whistle Blowing, Anti Money Laundering, Gifts, Hospitality and Registering Interests
 - Compliance with the Regulation of Investigatory Powers Act 2000

3. Key Activities

- 3.1 The three main documents considered by the Audit Committee annually are the Annual Governance Statement (AGS), the Statement of Accounts (SOA) and the Report to those charged with Governance (ISA 260). Each one has been considered in detail by the Committee in line with statutory deadlines
- 3.2 With regard to the AGS, there were no significant governance issues which needed to be identified in the statement for 2018/19. Good progress is being made on the list of ongoing actions set out in the Action Plan included in the Statement. Regular reviews will continue to be made throughout the year.
- 3.3 The SOA (post audit) was approved by Audit Committee on the 24 July in compliance with new, earlier, statutory deadlines introduced this year. In the external auditor's ISA 260 report, KPMG concluded that the authority "had proper arrangements to ensure it took properly informed decisions and deployed resources to achieve planned and sustainable outcomes for taxpayers and local people" and again issued an unqualified Value for Money opinion. Only one low priority area for improvement was identified, relating to a more frequent reconciliation of rateable value information provided by the Valuation Office Agency with information in the council's Northgate business rates system. Arrangements have been put in place to implement that recommendation.

Wyre Local Plan (2011 - 2031) - Proposed Main Modifications

1. Purpose of report

- **1.1** To present to Council the Inspector's Post Hearing Advice (the Advice) and submitted council response.
- 1.2 To ask that the council's response to the Advice in so far as matters fall within the responsibilities of the Council be confirmed. The Advice and submitted council's response are included in Appendix 1.
- 1.3 To present to Council the proposed Main Modifications (MMs) to the 'Publication' draft Wyre Local Plan (the Local Plan) and the Addendum to the Local Plan Sustainability Appraisal (SA) and to ask that the proposed MMs and SA Addendum be approved for a six week public consultation.

2. Outcomes

2.1 To progress the Local Plan to Adoption as required by the approved Local Development Scheme and Local Plan Regulations.

3. Recommendations

- 3.1 That the submitted response to the Inspector's Post Hearing Advice is confirmed in relation to matters falling within the responsibility of the Council and set out in paragraphs 5.5 5.14 below.
- 3.2 That powers be delegated to the Head of Planning Services to finalise the Addendum to the Sustainability Appraisal Report to accompany the Main Modifications to the 'Publication' draft Wyre Local Plan consultation and

approve it for public consultation as set out in paragraphs 5.19 below, in consultation with the Planning and Economic Development Portfolio Holder.

- 3.3 That powers be delegated to the Head of Planning Services to make any necessary changes to the Schedule of Main Modifications in response to the final conclusions of the Sustainability Appraisal and Habitats Regulations Assessment and any other editorial changes prior to publication, in consultation with the Planning and Economic Development Portfolio Holder.
- 3.4 That subject to the final findings in the Addendum to the Local Plan Sustainability Appraisal, the Schedule of Main Modifications to the 'Publication' draft Wyre Local Plan (Appendix 2) be approved for public consultation as outlined in paragraphs 5.19.
- That the final Schedule of Main Modifications to the 'Publication' draft Wyre Local Plan be approved for Development Management purposes.
- That powers be delegated to the Head of Planning Services to prepare necessary Additional Modifications to the 'Publication' draft Wyre Local Plan in consultation with the Planning and Economic Development Portfolio Holder which improve the clarity of the document and do not alter the substance of the document including factual and typing corrections.

4. Background

- 4.1 In September 2017 the Council approved the publication of the draft Wyre Local Plan for a six week public consultation. The draft Wyre Local Plan with a number of modifications was then submitted to the Secretary of State for examination into its soundness and legal compliance in January 2018.
- 4.2 As part of the examination, in March 2018, the appointed Inspector sent to the council two sets of Preliminary Questions which led to the submission of some further modifications to address issues raised by the Inspector. All modifications were considered by the Inspector as part of the hearing sessions held in May 2018. Further modifications were also submitted during the hearing sessions to address issues discussed at the hearings.

5. Key issues and proposals

5.1 The Inspector has given full consideration to all submitted evidence including the representations submitted in September 2017 and submissions at the hearings in May 2018. In July 2018 the Inspector issued his Post Hearing Advice (the Advice) to provide his views on some key issues and also guidance on necessary further main modifications.

- 5.2 The advice is set out in relation to a number of issues which the Inspector expects the council to address through main modifications to the Local Plan. In some instances the Inspector gives the council a clear direction on the proposed main modifications expected whilst in other instances he gives the council some discretion. Where the Inspector gives a clear direction, these are matters for the Executive and a Report was considered by Cabinet on the 5 September 2018.
- 5.3 Where the Inspector gives the council discretion, these are matters for Council and are set out below (paragraphs 5.5 5.14). The paragraph numbers in brackets refer to the paragraph numbers in the Advice.
- The Inspector required a prompt response to his advice. The response was considered by the Planning Policy Working Group and subsequently sent to the Inspector and also published on the council's website. The Advice with the council's response is attached in Appendix 1.

Strategy and Strategic Policies

- Plan housing land supply against the objectively assessed need. Although he accepts the highway evidence he nonetheless acknowledges that it is a high level study and concludes that more detail is necessary that would evidence 'severe' impact on the highway network and therefore justify a shortfall in housing land supply. He also acknowledges the need to have a Local Plan in place as soon as possible so that development in the borough is plan led.
- 5.6 The Inspector gave the council two options (paragraphs 11 and 12)
 - a) Option 1 to suspend this Local Plan and undertake additional highway work, and
 - b) Option 2 to proceed to adoption with necessary modifications but commence a review next year.
- 5.7 The submitted Council response indicates support for Option 2. It is considered that as noted by the Inspector it would be beneficial to proceed to adopt the Local Plan and establish an up to date policy framework for the consideration of planning applications. In supporting Option 2 and complying with the Inspector's recommendations, the council can demonstrate a five year land supply and therefore development would be plan led rather than ad-hoc on the basis of individual planning applications. The Council is asked to confirm support for Option 2.
- 5.8 The Inspector concludes that notwithstanding Local Plan highway evidence, some modest increases in housing provision in certain locations would not lead to severe residual cumulative impacts on the highway network. However in other locations for reasons other than highway impacts, he reduces the scale of development proposed.

Green Infrastructure

- 5.9 The Inspector considers that the definition of Green Infrastructure (GI) should not include all designated countryside (paragraph 24). Notwithstanding this the Inspector recognises that on the urban peninsula there may be merit for some of the remaining areas of countryside which are not otherwise protected as Green Belt to be also designated as GI recognising that they provide an important recreational resource / green lung as well as having landscape and biodiversity benefits. He therefore gives the Council some discretion to consider this matter.
- 5.10 There are four areas of countryside on the urban peninsula as shown on the Plan in Appendix 3. As shown in Appendix 3, it is considered that A and part of B should also be designated as GI whilst the remainder part of B and also C and D should be designated just as countryside. The part of B which is not designated as GI covers a caravan park and an electricity sub-station and therefore do not function as GI. C and D are part of the wider countryside extending into Fylde Borough and it would be inappropriate to consider them as GI in view of the Inspector's comments in paragraph 24 of the Advice. The Council is asked to confirm the approach to GI designations in relation to countryside areas on the urban peninsula as detailed shown in Appendix 3.

Site SA1/9 – South Stalmine, Stalmine.

5.11 The Inspector indicates that there is merit in allocating the land immediately to the south of the current built limits of the village in preference to the south western part of the proposed allocation (paragraph 29). This is demonstrated in the plans for Main Modification MM105 (Appendix D in the Schedule of Main Modifications included in Appendix 2 of this Report). The Inspector asks that the Council gives serious consideration to this option. The submitted council response indicates that the alteration the site allocation SA1/9 as suggested by the Inspector is supported. The Council is asked to confirm the alteration to the boundary of site allocation SA1/9 as detailed above.

Site SA1/13 Inskip Extension

- 5.12 The Inspector considers that the scale of the development proposed at Inskip under policy SA1/13 is too large and recommends changes to reduce the allocation. This matter is detailed in the report to Cabinet on 5 September 2018.
- 5.13 The Inspector also suggests that the Council considers whether a modest allocation should also be made on the field across the road from the pub to the south of the village. The submitted council response indicates that a modest allocation on the field across the road from the pub is considered appropriate. The field will have the capacity to accommodate 70 dwellings. The revised allocation at Inskip is therefore for 155 dwellings, which is 100

dwellings less than the proposal in the 'Publication' draft Local Plan. The Council is asked to confirm the inclusion of the field across the road from the pub within the allocation SA1/13 at Inskip.

Site SA3/4 – Forton Extension

5.14 The Inspector recommends changes to allocation SA3/4 at Forton which are detailed in the report to Cabinet on 5 September 2018. With regards to the location of 1 hectare of employment land required under allocation SA3/4, the Inspector makes two suggestions to the Council – first that it is located north of the existing employment site at Ashmead and second, that it is located to the east of the existing employment site of Jesmond Dene (see plan in Appendix 4). The submitted council response indicates that the location of the 1 hectare of employment land east of Jesmond Dene is considered more appropriate. It will enable the employment to be closer to the new facilities proposed in the new neighbourhood centre which will be of benefit to future workers. The location of the employment land close to the main area of housing growth will also encourage walking and cycling to work. The Council is asked to confirm the location of the 1 hectare of employment land to be east of Jesmond Dene.

Proposed Main Modifications

- 5.15 Main modifications have been prepared to comply with the Inspector's direction in the Advice and to accord with the published council response, including alteration to housing allocations and the approach to calculating the Local Plan housing land supply. The resulting increase in the Local Plan housing land supply is 1,060 dwellings raising the overall housing land supply to 9,285 dwellings or 464 dwellings per annum. The resulting shortfall has been reduced to 295 dwellings.
- **5.16** A Schedule of proposed Main Modifications is attached in Appendix 2. This is a consolidated schedule of all Main Modifications
 - prepared following consultation on the publication version of the LP (September 2017) and submitted to the Inspector with the publication version of the Local Plan in January 2018,
 - (2) produced in response to the Inspector's preliminary questions,
 - (3) put forward during the hearing sessions,
 - (4) prepared in response to the Inspector's Post Hearing Advice.
- 5.17 As required by planning legislation¹ the proposed Main Modifications must be subject to a sustainability appraisal. Planning legislation² requires that the authority preparing a Local Plan must do so "with the objective of contributing to the achievement of sustainable development". The Addendum to the Local Plan Sustainability Appraisal (SA) considering the social, economic and environmental impacts arising from the proposed

- Main Modifications, has not yet been finalised. A verbal report will be given at the Council meeting.
- 5.18 The proposed Main Modifications and the final SA Addendum Report must be subject to a minimum six week public consultation. All representations received will be forwarded to the Inspector for consideration as part of the Local Plan examination in public.
- 5.19 It is proposed to make the Schedule of Main Modifications to the 'Publication' draft Wyre Local Plan and the Addendum to the Sustainability Appraisal available for Inspection online, at the Civic Centre, and at all libraries in Wyre. A hard copy of the Schedule of Main Modifications to the 'Publication' draft Wyre Local Plan and the Addendum to the Sustainability Appraisal will be sent to all Parish and Town Councils to facilitate engagement with their local communities. The publication of the Schedule of Main Modifications to the 'Publication' draft Wyre Local Plan and the Addendum to the Sustainability Appraisal will be publicised on the council's website, through formal notices in local papers, a press release, on social media and by direct communication to all persons and organisations on the Local Plan Consultees database including all those who made representations at the previous consultation stage. The proposed approach complies with the 2010 Statement of Community Involvement.

Habitat Regulations Assessment

5.20 A revision to the Habitats Regulations Assessment (HRA) accompanying the Local Plan was necessary in order to comply with new case law and also to take account of the proposed Main Modifications. A revised HRA is being prepared and will be forwarded to Natural England (NE) for formal consultation. Since NE has been involved in the process it is not expected that there will be comments requiring further substantive changes to the draft Wyre Local Plan. Once the HRA has been endorse by NE, it will be submitted to the Inspector and published on the council's website. A verbal Report will be given at the Council meeting on the revised HRA.

<u>Development Management</u>

5.21 In September 2017 the Council approved the 'Publication' draft Wyre Local Plan for Development Management purposes replacing the Core Strategy Preferred Options in the Development Management process from the date of publication. The publication of proposed Main Modifications is an advanced stage in the examination process and thus local plan process. It is requested that Members approve the proposed Main Modifications to the 'Publication' draft Wyre Local Plan for Development Management purposes.

What happens next?

5.22 As noted above the Sustainability Appraisal (SA) and HRA have not been yet been finalised. Further Main Modifications may be necessary to take

account of the final conclusions from these assessments. In order to meet the timetable recommended by the Inspector, and avoid further delays, the Council is requested to delegate powers to the Head of Planning Services in consultation with the Planning and Economic Development Portfolio to finalise the Addendum to the SA and approve it for public consultation. The Council is also requested to delegate powers to the Head of Planning Services to make any necessary amendments to the Schedule of Main Modifications in response to the final conclusions in the Addendum to the SA Report and the HRA.

- 5.23 There may also be a need to make minor changes e.g. to correct minor errors or improve the clarity of the draft Local Plan itself and the Schedule of Main Modifications. The Council is requested to delegate powers to the Head of Planning Services in consultation with the Planning and Economic Development Portfolio Holder to make any additional minor modifications to cover editorial changes to the Schedule of Main Modifications before it is published and also to the draft Wyre Local Plan itself.
- 5.24 After the six week publication period, the council must collate the representations it receives and then forward them to the Planning Inspector. The representations must be summarised and responded to individually for the Inspector. The Inspector will consider the matters raised in the representations before finalising his report. In his Post Hearing Advice, the Inspector indicates that he does not anticipate the need for additional hearings should Option 2 (early review) be pursued. However if he finds that additional hearings are necessary they will be held in late 2018 or early 2019. Assuming no additional hearings are necessary the Inspector indicated that he will finalise his report in December 2018.

Equality Impact Assessment, (EqIA)

5.25 The proposed Main Modifications have been subject to an EqIA to ensure compliance with public sector equality duty created under the Equality Act 2010. An Addendum to the Local Plan Equality Impact Assessment has been prepared.

WYRE LOCAL PLAN EXAMINATION

INSPECTOR'S POST HEARING ADVICE – MAIN MODIFICATIONS AND RELATED MATTERS

Please reply to the Programme Officer

The Council's Response is indicated in red below.

Introduction

- 1. The purpose of this note is to provide advice on some key issues and my views on the further Main Modifications (MMs) that are likely to be required to make the Wyre Local Plan (LP) sound following the hearing sessions. The MMs are in addition to those potential MMs (1) prepared by the Council in advance of the hearings following consultation on the publication version of the LP (September 2017), (2) produced in response to my preliminary questions and (3) put forward during the hearing sessions. In addition to possible **MMs** which I have highlighted in bold the note seeks clarification/further information from the Council on some matters following the hearings. Paragraph references are from the tracked changes version of the LP prepared to assist during the hearings.
- 2. I would also advise that I have given full consideration to all the representations made about the LP including the oral contributions at the hearings. My final conclusions regarding soundness and procedural compliance will be set out in the report to be produced following consultation on the proposed MMs. Nevertheless, having regard to the criteria for soundness and to assist at this stage, I shall provide brief explanations for my advice thus far.
- 3. My findings may alter in the light of any further evidence that emerges including the consultation process. My views are therefore given here without prejudice to the conclusions that will appear in the report. I do not comment on every issue in this advice. My final report will cover other main issues that arose during the examination but which are not dealt with in this note.

The Council thanks the Inspector for the interim advice within the 'Post Hearing Advice Note'. The Council's response is given in turn following the Inspector's comment.

<u>Matter 1 – Legal Compliance, Procedural Requirements and the Duty to Cooperate</u>

Issue 3 – Sustainability Appraisal (SA) and Habitat Regulations Assessment (HRA)

4. The SA considers the options for spatial distribution at Section 4 but does not appear to assess the likely significant effects of implementing the Objectively Assessed Need (OAN) of 9,580 dwellings (479 dpa) or reasonable alternatives within the OAN range of 457 to 479 dpa. The SA only appears to assess the

effects of the delivery of 8,224 dwellings (411 dpa)¹. As the SA is a continuing process and will need to be updated to take into account MMs already proposed and the advice elsewhere in this document, the opportunity should be taken to remedy these omissions.

The Council will undertake a SA of the minimum and maximum figures of the OAN range - 457 to 479dpa. The Council will also undertake a SA of the new annual LP housing requirement figure arising from the modifications indicated below.

The SA will cover all proposed MMs to the 'Publication' draft LP which will be the subject of public consultation. These include MMs submitted prior and during the hearing sessions in May and also arising from the Inspector's Post Hearing Advice and other comments below. It should be noted that some MMs submitted prior and during the hearing sessions may be altered as a result of the advice below.

5. I welcome the Council's commitment to undertake further work on the HRA in view of the recent judgement as set out in EL5.031.

Matter 2 - Strategy and Strategic Policies

Issue 1 - The Spatial Distribution of Development

- 6. The Council suggests that the only strategy possible is that of 'managed dispersal' primarily because of highway capacity and flood risk constraints. In terms of flood risk constraints there is sufficient land around the higher order settlements of Poulton-le-Fylde, Thornton, Garstang, Great Eccleston, Preesall, Hambleton and Catterall which is beyond Flood Zones 2 and 3 to support an alternative strategy and indeed meet the full OAN. Therefore, flood risk should not be seen as an overriding constraint on its own.
- 7. Highway capacity has the effect of not only limiting the strategy options but also constraining the ability to meet the OAN. As a result the evidence on highway capacity is a fundamental component of the evidence base. Lancashire County Council's (LCC) report (ED094a) is helpful in understanding the constraints of the options and particular settlements/sites. However, it is necessarily a high level primarily desktop assessment. Moreover, although having regard to committed schemes, it does not appear to robustly model how new transport infrastructure could cost effectively limit the significant impacts of development.
- 8. Proposed transport infrastructure includes the committed highway improvement schemes within the Infrastructure Delivery Plan (IDP), the Poulton-le-Fylde Highway Mitigation Strategy, the A6 Corridor Highway Mitigation Strategy and other off-site improvements which could be developed to mitigate localised highway impacts. Some of these planned and potential improvements do not appear to have been taken into account as measures to mitigate adverse transport impacts now so that the LP plans positively for the development and

infrastructure required.

- 9. Moreover, the need to focus significant development in locations that can be made sustainable and where the use of sustainable transport modes can be maximised is in my view not given sufficient weight in the analysis and highway caps. For example along the A6 corridor affected by the Severe Restriction Zone (n1) there are existing and proposed employment opportunities, a range of services and facilities, particularly in Garstang, and the opportunity to use and build upon sustainable modes of travel. Similar factors would apply in Poulton-le-Fylde and to a lesser extent in Thornton. In contrast the 'managed dispersal' strategy is likely to increase the reliance on the private vehicle and longer distance travel.
- 10. However, I also appreciate the need to get a LP in place as soon as possible so that development is plan led, policies are up-to-date, and allocations can be made which would boost the provision of housing and ensure a 5 year supply.
- 11. There appear to be two ways that the above highway and transport issues could be dealt with. Option 1 would be to robustly review the highway and transport evidence during the examination. This would require suspension of the examination whilst the additional work was undertaken.
- 12.Option 2 would be to build an early review mechanism into the LP as suggested by the Council during the hearings. However, should this option be pursued there should be a commitment to undertake this partial review as soon as possible with the objective of submitting for examination within 3 years of the adoption of the LP. Such a commitment should be supported by a specific policy (MM).

The Council is thankful to the Inspector for suggesting a way forward that would enable the Council to proceed to adoption of this Local Plan without delay. The Council supports Option 2 and will prepare a **MM** to insert a new policy that would commit the Council to starting the partial review of the plan with the objective of meeting the full OAN, before the end of 2019 with submission by early 2022. The partial review will cover an update of the OAN and a review of transport issues and highway capacity.

- 13. With both options more work would be required on highway constraints and transport infrastructure in the form of:
 - (i) More robust modelling of the likely mitigating effects of the committed transport and highway schemes;
 - (ii) Reviewing LCC's approach to severe congestion and severe residual cumulative impacts. Is the level of congestion severe and the LCC approach comparable with other authorities?;
 - (iii) Reviewing whether LCC has put enough emphasis on sustainably located sites where the use of sustainable transport modes can be maximised in analysing congestion and highway impacts and applying the highway caps.
 - (iv) taking into account the policies and allocations of the LP.

The purpose of both options would be to ensure that OAN would be met by allocating more sites alongside the necessary infrastructure.

- 14.In terms of the review option, work on updating the evidence base relating to the transport network would need to be commenced as soon as possible after the adoption of the LP.
- 15.In addition in relation to the review option I am mindful that the standarised approach to calculating housing needs may be part of Government policy by the time of a review. However, whatever policy is in place at the time of review would need to be considered.
- 16. Notwithstanding the highway caps derived from ED094a I see opportunities for some modest increases in housing provision in some locations which would not lead to severe residual cumulative impacts based on the existing evidence base and representations. There are other locations where for reasons other than highway impacts I find the scale of allocations unsound. In this context I set out below further detailed comments and suggested MMs which when taken together would increase housing supply and bring overall provision closer to the OAN.

As indicated below the Council is supportive of the suggested MMs. The overall increase in the Local Plan housing land supply is 1,060 dwellings raising the LP housing land supply to 9,285 dwellings or 464 dpa.

Issue 4 - Strategic Areas of Separation

17. The Strategic Area of Separation (SAS) between Forton and Hollins Lane would be significantly eroded by the allocations within the LP. I return to this matter below when considering the allocations.

Issue 5 - Green Belt

18. With regard to Parcel 11 the small 0.7 ha parcel of previously developed land on the Norcross Lane frontage forms part of the development area which has outline planning permission and would not be used as open space. Therefore, the Site Assessment forming part of the Green Belt Study (ED109b) is out of date. Having regard to the characteristics of the 0.7 ha parcel and the planning position I consider that exceptional circumstances exist and that this area should be removed from the Green Belt (MM).

The Council accepts the Inspector's recommended change and will prepare an appropriate **MM**.

Matter 3 - Housing and Employment OAN and Requirements

Issue 4 – The Housing Requirement

19.I have concerns about the failure of the LP to meet the Housing OAN requirements and have suggested two options to remedy this as set out above.

Matter 4 - Housing Land Supply

Issue 1 – Components of Housing Supply

20.The assessment of completions on non-allocated housing sites of less than 25 dwellings since 1 April 2011 (EL5.012) indicates to me that there is a justification for a windfall allowance within the range of 25-50 dpa. This would be an additional component of the supply but would only take effect after say 31 March 2021 so not to lead to double counting of commitments (sites with planning permission at 31 March 2018). Windfalls would add between 250 to 500 dwellings to the supply. Paragraphs 7.2.2 and 7.2.3 should be modified accordingly (MM).

The Council accepts the Inspector's suggested amendment to add a windfall allowance in the housing land supply calculation and will prepare appropriate modifications to paragraphs 7.2.2 and 7.2.3 which will also be reflected in the Housing Implementation Strategy. The Council considers that an annual windfall allowance of 50dpa is justified.

Issue 2 – The Housing Trajectory

21.Applying the substantial shortfall of 836 dwellings to the next 5 years requirement through the Sedgefield approach would not be realistic as it would set a 5 year housing requirement that is unlikely to be delivered and would risk the LP being out-of-date soon after adoption. Therefore, I agree that spreading the shortfall over the Plan period is justified (the Liverpool approach).

The Council is pleased that the Inspector has accepted the Liverpool approach.

Issue 3 – Five Year Housing Land Supply

22. Since the 2011 base date of the LP completions have not exceeded the OAN of 479 dpa in any year and only exceeded the housing requirement of 411 dpa in one year (2016/17). Using the Regional Spatial Strategy requirement to judge delivery since 2011 (206 dpa) would not be appropriate as it is not anyway near the OAN for the period 2011-18. As Wyre has only met its housing target in 1 out of 7 years since 2011, there has been a record of persistent under delivery so a buffer of 20% should be applied in accordance with paragraph 47 of the National Planning Policy Framework (NPPF). Paragraph 7.2.7 of the LP will need to be modified accordingly (MM). The evidence appears to indicate that there would be a 5 year supply of housing land on adoption of the LP using the Liverpool method to address the shortfall and applying a 20% buffer.

The Council accepts the Inspector's recommendation and will prepare an appropriate modification to paragraph 7.2.7 to make reference to a 20% buffer. The modification will also be reflected in the Housing Implementation Strategy. Using the new annual figure of 464dpa and applying the Liverpool approach and 20% buffer the Council can demonstrate 5.19 years of land supply on adoption.

23. Applying the lead in times and build out rates from the Housing Background Paper (HBP) (ED010) suggests that some sites may deliver more housing within the LP period than projected. This would allow an upward adjustment in the

number of houses that could be delivered in the LP period taking the total closer to the OAN. I return to specific sites and delivery when I deal with the allocations below.

<u>Matter 7 - Core Development Management Policies</u>

Issue 4 - Natural and Historic Environment Policies

24. The definition of Green Infrastructure within Policy CDMP4 (Section 4) is too wide ranging. To include all countryside areas goes well beyond the definition within the NPPF as many such areas are not multi-functional and cover large expanses of agricultural land in Over Wyre and to the east of the Fylde Peninsula up to the Forest of Bowland. That said I can appreciate the need to maintain most of the remaining areas of countryside on the peninsula which are not otherwise protected by Green Belt as the areas provide an important recreational resource/green lung as well as having landscape and biodiversity benefits. In this respect the definition of Green Infrastructure within Policy CDMP4 should be modified (MM).

The Council accepts the Inspector's recommendation and will prepare an appropriate modification to the definition of Green Infrastructure within Policy CDMP4.

The Council considers that parts of countryside areas on the urban peninsula (as shown on the Policies Map) should also have a GI designation for the reasons indicated by the Inspector above. The Council will prepare an MM to show which parts should have the additional GI designation.

Within the wider countryside areas in Over Wyre and to the east of the urban peninsula the intention is to identify specific GI sites on the same basis as GI within settlement boundaries. Using existing evidence and knowledge, the sites within countryside areas which will also have a GI designation relate to public open space, outdoor sport, sites of ecological and geological interest, church grounds, cemeteries and school plying fields. This is consistent with the approach within settlement boundaries.

The Wyre Estuary and Morecambe Bay which was not shown as part of the countryside but which is a designated SPA site, will be shown as GI up to the low tide mark.

Matter 8 - Allocations

Site SA1/2 - Lambs Road/Raikes Road, Thornton

25. The separate parcel of land to the south of Raikes Road has landscape and recreational attributes providing a green link between the built up area of Thornton and the more extensive areas of countryside towards the River Wyre and Skippool Creek. It has public footpaths along two boundaries. Access is via narrow lanes. In addition a new road from Skippool Road (Thornton Mews) may not be necessary or deliverable and would have some adverse impacts. This part of the allocation should be deleted (MM).

26. Notwithstanding the recommended change to the allocation and based on the evidence I consider delivery of 360 dwellings from the remaining part of SA1/2 within the LP period is realistic.

The Council accepts the Inspector's recommendation and will prepare an appropriate modification to remove the parcel of land to the south of Raikes Road. The Council agrees that the site can deliver 360 dwellings within the LP period.

The parcel of land removed from Site SA1/2 will be designated as countryside and possibly GI as per response to paragraph 24 above.

Site SA1/8 - South of Blackpool Road, Poulton-le-Fylde

27. The site extends to almost 20 ha but is only shown as delivering 154 dwellings. Whilst there are constraints affecting the site (highway, flood risk, railway line) and there is a need to provide land for a new primary school and a car park, the site is in an accessible location within walking distance of the town centre and railway station. There is scope to provide walking and cycling links across the site combined with Green Infrastructure which would make walking and cycling from the site and other areas to the north and west of the site more attractive. A larger number of houses would allow a greater contribution to the Poulton-le-Fylde Highway Mitigation Strategy and off-site sustainable transport measures. The opportunity to make best use of the site should be taken and the numbers to be delivered should be increased. For the reasons given above and notwithstanding the highways cap the Council should reassess the capacity of the allocation and the LP should be modified (MM).

The Council accepts the Inspector's conclusions and has reassessed the capacity of the allocated site.

The site includes a large area of flood risk (6.6 hectares) and can be distinguished into two parts separated by a former rail embankment. Berry's Lane runs along the top of the embankment giving access to two farms (which are excluded from the allocation). 1hectare of land between the two farms is effectively landlocked. Taking into account the requirement to provide a car park (circa 0.23 hectares), the Council considers that the site could deliver around 300 dwellings. The whole allocation can be delivered within the local plan period.

Site SA1/11 - North of Norcross Lane

28.Adjustments should be made to the Policies Map to reflect the comments made at paragraph 18. Does the site capacity and site delivery need to be adjusted as the allocation is to be extended? This was not entirely clear to me from discussion at the hearings.

As indicated above under paragraph 18, the Council accepts the Inspector's recommendation to remove from the Green Belt the parcel of land with planning permission and include it within the allocation and will prepare a MM to that effect.

Despite the increase in site area, following a pre-application meeting with a housebuilder preparing a reserve matters application on the majority of the site, the overall capacity of the allocation is reduced to 300 because of the presence of peat which limits the developable area

of the allocation. The figure of 300 takes into account the number indicated by the housebuilder (219 dwellings), plus 70 sheltered accommodation dwellings (part of the original outline planning permission on the parcel to be released from the green belt) and a further 12 dwellings on the remainder 0.4hectares not covered in the forthcoming reserved matters application. The Council considers that the whole allocation can be delivered within the Local Plan period. Despite the reduced overall capacity of the site, 30 additional dwellings will be delivered within the local plan period.

Site SA1/9 - South Stalmine, Stalmine

29.There would appear to be logic to allocating STA_20 as an alternative to STA_16 as it is physically well-related to the village, there are no known constraints (other than the highways cap) and evidence indicates that it is deliverable (access via STA_05 and subject to a planning application). This option should be given serious consideration by the Council.

The Council has given consideration to the Inspector's recommendation and agrees that STA-20 is preferable to STA-16. The revised site allocation SA1/9 has a capacity of 180 dwellings.

Site SA1/13 - Inskip Extension

- 30. There are a number of adverse impacts that would arise from this allocation notably effect on the character and appearance of the village and its countryside surroundings, loss of Grade 2 agricultural land, relatively remoteness from many services and sources of employment, reliance on the private car for most trips which would involve relatively long journeys along a network of rural B and C roads, encouragement of commuting and implications for climate change. Cumulatively these adverse impacts indicate to me that the scale of allocations would be too large. Indeed the 255 dwellings appear to derive principally from highway capacity considerations. In addition I would question whether the site would deliver as anticipated.
- 31.A modest scale of allocation would be justified to enhance and maintain the vitality of the village but this should be confined to the area which already has planning permission and the land allocated either side of the school (MM). Such land would be well-related to the school and allow extension of the school if necessary. The Council may wish to consider whether a modest allocation at Site INS_07 would also be justified having regard to the recent advice from HSE (EL5.027).

The Council accepts the Inspector's recommendation and will prepare an appropriate modification to delete land north of Preston Road which does not have planning permission. The land to the east of the school including the land with planning permission (55 dwellings) has capacity for 85 dwellings allowing for access to be maintained to the farm. The Council considers that the land to the west of the school should be used for the expansion of the school.

The Council considers that a modest allocation at site INS-07 of 70 dwellings would be appropriate and will prepare a MM to that effect.

The allocation at Inskip will therefore be for 155 dwellings.

Site SA1/16 - West of Cockerham Road, Garstang

32. The development may need to deliver a primary school. In this respect it is questionable whether sufficient land has been allocated to allow delivery of the school and 100 dwellings. Moreover for the reasons given in paragraph 7-9 and based on the existing highways evidence base there is scope for a modest increase in housing delivered in Garstang. Additional land to the west of the allocation is well-contained and could be considered to not have significant landscape attributes. The technical constraints identified in the SHLAA (access, electricity lines, public right of way) can be overcome by master planning. Questions were raised about delivery at the hearings but the larger site is being promoted by a national housebuilder. I recommend the extension of the allocation so that it has an overall capacity of 200+ dwellings (MM).

The Council accepts the Inspector's recommendation and will prepare a MM to extend the boundaries of site allocation SA1/16 to the west to include all the land within the triangle bounded by Nateby Crossing Lane, Croston Barn Lane and Cockerham Road. The capacity of the new site is 260 dwellings and the Council considers that it can be delivered within the local plan period.

Site SA1/17 - Land south of Prospect Farm, West of Garstang

33. For the reasons given in paragraph 7-9 and based on the existing highways evidence base there is scope for a modest increase in housing delivered in Garstang. Taking into account the size of the allocation a small increase in the site capacity is recommended (up to 70 dwellings) (**MM**).

The Council accepts the inspector's recommendation and will prepare an appropriate MM to increase the site capacity to 70 dwellings.

Site SA3/3 – Land west of Great Eccleston

34. The rate of delivery should be increased so that it is consistent with the HDP. The site is capable of accommodating two developers. Although the HDP refers to Great Eccleston being an untested market area it is an attractive location and vibrant settlement. The development company support a higher rate of delivery. Delivery should be increased to 50 dpa from at least 2025/26, leading to an additional 60 dwellings being delivered in the LP period (MM).

The Council accepts the Inspector's recommendation to revise the trajectory in relation to this site using the standard lead in times and built out rates. This results in the entire allocation being delivered within the local plan period.

Site SA3/4 - Forton Extension

- 35. The decision to make large scale allocations at Forton appear to derive principally from highway capacity considerations elsewhere. The parcels of land to the south and east of Sunnybank Nurseries significantly erode the gap between the settlements of Forton and Hollins Lane and undermine the SAS. Moreover, development on these sites would be poorly related to the existing settlement structure and could not form an 'organic extension' to Forton appearing as satellite housing estates. In addition they would be some distance from the hub of services in Forton (primary school, village hall, open space/recreational facilities and potential convenience store). Finally there is evidence that that the amount of land allocated at Forton is in excess of that required to deliver the anticipated capacity of 468 dwellings.
- 36.I have taken into account the suggested MM to include an area of Green Infrastructure on the southern part of the allocation (EL5.028) and the potential to provide a landscaped corridor along the A6. However, even with this mitigation development of these parcels would still close the gap between the settlements.
- 37.I acknowledge the Parish Council's preference for some of the southern parcel to be developed rather than the westernmost parcel. However, although the latter would have some landscape impacts it would be capable of being designed as an 'organic extension', would provide scope for an extension of the primary school and would be closer to village facilities.
- 38. With regard to employment I support the need to bring forward at least 1 ha of employment land at this location. In this respect allocation of a 1 ha parcel of land on the A6 north of the existing employment site at Ashmead would be one option. The site would have direct access to the A6, be adjacent to an existing employment use and would not materially erode the SAS. Although isolated from the remainder of the allocation it should be included in the master planning process. The alternative would be to include 1 ha of employment land to the east of Jesmond Dene (existing employment). I would welcome the Council's view on these options (or alternatives).
- 39.In conclusion I recommend that the allocation at Forton be amended to delete the parcels to the south and east of Sunnybank Nurseries (**MM**). The site capacity and delivery figures will also need to be adjusted albeit the Council's trajectory and representations indicate that at least 340 dwellings could still be delivered in the LP period based on realistic delivery of a maximum of 40 dpa.

The Council accepts the Inspector's recommendation to delete the parcels of land to the south and east of 'Sunnybank Nurseries' from the housing allocation SA3/4. The Council will prepare an appropriate MM.

The Council is of the view that the parcel on the east side of the A6 and the two fields fronting onto the A6 between Sunnybank Nurseries and Ashmead should be designated as part of the Strategic Area of Separation between Forton and Hollins Lane.

The Council considers that the 1 hectare of employment land should be located east of Jesmond Dene. The location of the employment land within the allocation at Forton and thus close to the facilities in the new neighbourhood centre will benefit future workers. The location of the new employment at Forton will also better relate to the main area of housing growth and encourage walking and cycling.

The capacity of the revised site is 310 dwellings using the methodology applied elsewhere in the LP.

Future Timetable

- 40.If the Council favour Option 1 as a way forward (paragraph 11 refers) an indicative timetable should be provided for carrying out the work as soon as possible.
- 41.If Option 2 is favoured the Council should prepare a composite Schedule of Proposed Main Modifications (MMs). This schedule should include MMs which have arisen since the publication of the LP, including potential MMs discussed at the hearings and those recommend in this post hearings advice. Supporting documentation such as an updated SA and HRA and the Housing Implementation Strategy (HIS) would also be required. An indication of the likely timetable for these tasks would be helpful. That said I would anticipate that the Schedule could be finalised by the end of August 2018 by the latest Based on this expectation the timetable for the remainder of the examination could pan out as follows:
 - September October 2018 publicity/consultation on MMs alongside updated SA/HRA and HIS for a 6 week period.
 - November 2018 Council and then the Inspector consider representations on MMs.
 - December 2018 Inspector finalises report. The report will be subject to QA and a LPA fact check as described in the Procedural Practice in the Examination of Local Plans (page 9) – see link below – which would probably take place in January 2019.

The Council considers that a six week consultation on MM alongside an updated SA/HRA and a Housing Implementation Strategy (HIS) September/October 2018 is achievable.

42.I would not anticipate the need for additional hearings should Option 2 be followed. However, if they are found necessary an additional 2 months should be built into the programme in late 2018/early 2019 to accommodate them.

Response

- 43.A response to this note should be provided as soon as possible. It would be particularly appreciated if any comments on the timetable could be provided quickly so that I can ensure that my future work and other commitments do not prevent expeditious progress on the remainder of the examination.
- 44. This advice should be published on the website as soon as possible. The Council's response should also be published once prepared. However, it should be emphasised that no representations on the contents of this note and the Council's response should be submitted at this stage. Representations will be invited on MMs once these are published. This note and the Council's response will form background documents to the MMs.










Main modifications to Polices Map (extract)






Main modifications to Polices Map (extract)






Main modifications to Polices Map (extract)






Main modifications to Polices Map (extract)




