We are residents at number Prudy Hill and have some concerns about the work carried out at The Cube, included in the planning application.

The planning application and works carried out so far mean we now have a very high wall at the back of our garden, which we do enjoy as much as possible, now the view is almost prison like and stops the light in our garden. The natural light is important to us, we love our time in our garden and more so during the last few months when we've not been able to visit friends and family or go out, yet the natural light from the sun is worse now than ever before, we will probably not see any natural light in the spring sun until much later in the day due to the height of this wall.

We also don't agree with the application of an extension of licence laws in the rear beer garden, we have serious concerns about this and the current 9pm licence law is late as it is and not really the official closing time. There was a day recently that at 5.30pm a fight broke out in the new garden; no staff were in attendance and no one to stop the fight. Fights will happen when people are not supervised but encouraged to drink alcohol all day and through to the night. I believe the actual licence for this premise is 6pm, therefore we would like to know why they are allowed to continue to 9pm with no questions or closures, clearly a breach on behalf of the council and police.

Knowing how things develop in there, believe me, we hear it all, I do not see how a 10pm licence would be beneficial or helpful. They do not staff it, people get rowdy and argue and fights break out and the noise levels increase as the drink flows and the garden fills up.

The garden planning permission makes way for an all year round garden now, therefore where before we had to put up with noise and fights until 9pm for about 5 months of the year, they are proposing 12 months of the year until 10pm! It is not acceptable, and these houses were here long before that beer garden, therefore if anything should be considered, it is the impact The Cube is having on residents' lives.
