Re: Draft Wyre Licensing Policy 2021-2025

We have had the opportunity of perusing the above document and would like to make the following comments:

- as in previous years we are still concerned about the "litter/cigarette debris" outside licensed/takeaway premises, more receptacles should be provided – this would appear not to have been monitored or addressed and needs to be enhanced. All licensed premises have a duty of care in their locations.
- closing time – licensed/takeaway premises to be limited to closing at 02.00hrs to avoid if at all possible antisocial behaviour particularly along Lord Street Fleetwood which it is proposed to have new residential flats over existing shops.

I attach copy of our letter of 21<sup>st</sup> October 2015 with comments attached which as you will see are the same as above – nothing seems to have been addressed.

We trust you will take these comments into consideration when re-drafting the above Policy.

Paragraph

14.3.5 Fleetwood Civic Society is particularly concerned with the litter” aspect of licensed and in fact all premises. We would hope that “Wyre key message - all premises 20 – any area used for smoking by patrons must be supervised and cigarette debris cleared away on a regular basis, including at the end of trading”.

We have written to the Council on many occasions regarding cigarette debris outside not only licensed but almost all premises not being cleared and have been advised this constitutes a breach of the bye-law. There must be a pro-active responsibility on the part of the licensee/takeaway proprietors/taxi offices and all trading premises to ensure this problem is rectified with availability of Wyre officers to encourage effective remedies. Nearly all premises do not have adequate receptacles available for disposal of such debris. On reading the “Wyre’s statement” we believe that all license holders/traders have a duty of care to clear their own frontages and immediate surroundings. All the litter debris we consider to be a “public nuisance” and enforcement to clear and tidy up is paramount.

The effects of all the cumulative litter around the Borough does not assist to encourage more footfall and ambiance for residents and visitors to the many facilities on offer.
