Provision of electric vehicle charging points for the licensed taxi trade

1. Purpose of report

- 1.1 To approve the relocation of the taxi licencing electric vehicle charging point from the Garstang High Street car park to Thornton Little Theatre car park.
- 1.2 To provide the Head of Environmental Health and Community Safety delegated authority to relocate the proposed electric vehicle charging point at Wheatsheaf Way car park, Poulton to the Civic Centre car park in the event that the cost of installing the charging point on the former is financially unviable.

2. Outcomes

- 2.1 Charging points will be provided for electric powered vehicles on council car parks as part of the Council's Business Plan response to climate change.
- **2.2.** The taxi trade scheme identified in the original report (Installation of electric vehicle charging points on Wyre Council Car Parks 4 September 2019) will commence to installation.

3. Recommendations

3.1 It is proposed that taxi only charging points are installed at Fleetwood's Custom House Lane car park, Cleveleys' Rough Lea Road car park, Thornton's Little Theatre car park and in Poulton at either Wheatsheaf Way or the Civic Centre car park.

- 3.2 To permit the Head of Environmental Health and Community Safety to approve a change in the location of the taxi only charging point in Poulton from Wheatsheaf Way car park to the Civic Centre car park if necessary owing to financial viability.
- 3.3 The charging point originally planned for Garstang's High Street car park will be moved to Thornton's Little Theatre car park owing to the level of existing provision within Garstang which has been assessed as sufficient.

4. Background

- A procurement exercise has been completed by the six successful Local Authorities through the NHS CPMI framework mini competition route and the supplier Electric Blue were identified as the successful supplier.
- 4.2 A review of all 24 sites across the six Local Authorities was undertaken by Electric Blue, and unfortunately the estimated cost of installing the charging point on Garstang's High Street car park meant it was unviable for Electric Blue to install the site at this location (see Appendix A).
- **4.3** Garstang is in the fortunate position of being serviced by a number of rapid electric car charging points in the Booths car park.
- 4.4 Thornton at present is not serviced by an electric rapid car charging point and Electric Blue have agreed to locate one at Thornton's Little Theatre car park as an alternative.
- 4.5 Whilst Electric Blue originally planned to locate the Poulton electric car charging point on the Wheatsheaf Way car park, it appears that this would involve closing Wheatsheaf Way road to complete the work. Wheatsheaf Way road is essential to the safe running of traffic in Poulton during peak times. Therefore the work would have to be undertaken during unsocial hours thus increasing the cost of installing the equipment on this site. The increased cost is not yet known, however if the cost is more than the budget available, it is proposed that the equipment will be installed on the Civic Centre car park instead.
- 4.6 These are the last two sites to be agreed for the whole of the project which means Wyre could be responsible for delaying its implementation. By having the freedom to change sites if necessary, the delay will be minimised.
- 4.7 The two remaining sites identified in the original report remain unchanged. The ongoing revenue costs, including maintenance, insurance and electricity costs will be met by the supplier for a period of 10 years.

5. Key issues and proposals

- **5.1** The charging point originally planned for Garstang's High Street car park will be moved to Thornton's Little Theatre car park
- 5.2 The charging point in Poulton will either be located on Wheatsheaf Way car park or the Civic Centre car park depending on the financial viability of installing the equipment at each site.

6. Delegated functions

6.1 The matters referred to in this report are considered under the following executive function delegated to the Neighbourhood Services and Community Safety Portfolio Holder (as set out in Part 3 of the council's constitution): "To consider options and proposals to improve, preserve and maintain those neighbourhoods and places which local people consider valuable for conservation, commerce and daily living."

Financial and legal implications						
Finance	There are no land disposal implications created by this report as all 'spaces' will remain in the council's ownership. The report assumes a revenue neutral impact on our car parks owing to the small number of spaces affected and the burden of costs remaining with the suppliers.					
Legal	Formal agreements will be entered into with the three schemes' operators to ensure no liabilities fall on the council during the lifetime of the units or future beneficial opportunities are restricted.
