Allocation of S106 monies to improve Pheasants Wood, Thornton

Key decision: No

1. Purpose of report

1.1 To seek approval for the allocation of S106 funds from the development at The Bourne Poacher, 325 Fleetwood Road North, Thornton to undertake improvements at Pheasants wood, Thornton and for the scheme to be added to the 2023/24 Capital Programme.

2. Corporate priorities

- **2.1** To Improve the health and wellbeing of our communities
- **2.2** Facilitate improvements and increase accessibility for users of parks and opens spaces.
- **2.3** Creating wider environmental benefits by increasing wildlife and biodiversity.

3. Recommendations

- 3.1 That the Council's 2023/24 Capital Programme be amended to include improvements to Pheasants Wood using £14,648 (which includes indexation) received through the S106 obligation relating to planning permission 17/00469/FULMAJ.
- 3.2 That approval is given to authorise the Corporate Director Environment to appoint contractor(s) and supplier(s) in accordance with the Council's Financial Procedure Rules.

4. Background

4.1 Planning permission was granted in February 2018 following the demolition of the former Bourne Poacher public house, Thornton-Cleveleys to erect retirement apartments and a retail unit with the developer contributing £14,648 towards green infrastructure improvements in Pheasants Wood, Thornton.

5. Key issues and proposals

- 5.1 To use the S106 money to improve and deliver green infrastructure improvements to Pheasants Wood, owned by Wyre, which include enhancements to existing paths, creating a boardwalk feature overlooking the pond, improvements to access points and site specific interpretation material.
- To collaborate with the Friends of Pheasants Wood to provide and develop opportunities to encourage wider community involvement with the installation of bird and bat boxes and the development of interpretation material for the site.
- 5.3 It is a condition of the S106 obligation that the funding is spent on this site and these specific improvements are carried out by 29 November 2028.

6. Alternative options considered and rejected

6.1 Should this scheme not go ahead and the S106 monies are not used as prescribed in the agreement, the council shall refund the party who paid it together with any interest accrued. The council would not be compliant with its obligation under section 106 of the Town and Country Planning Act 1990.

7. Delegated functions

7.1 The matters referred to in this report are considered under the following executive function delegated to the Open Spaces Portfolio Holder (as set out in Part 3 of the council's constitution): "To consider matters relating to parks, open spaces, playing fields, playgrounds and allotments".
