I have reviewed the GovNet publication below and believe that it is not reflective of the Procurement Act 2023 as enacted.

Within the new act, the thresholds used are the same as those used in Public Contracts Regulations 2015.

Regulated below – threshold contracts in the new act that are classed as "notifiable below-threshold contracts" for non-central government authorities have a threshold of not less than £30,000. This figure I believe is inclusive of VAT so the net threshold is £25,000. As of the 1stJanuary 2022 all thresholds under Public Contract Regulations 2015 became inclusive of VAT.
