Acceptance of grant funding to provide healthy weight services and an active travel programme in Wyre

Key decision: No

# 1. Purpose of report

1.1 To request acceptance of £372,735 of funding from Lancashire County Council (LCC) Public Health Team to provide healthy weight services for adults and children in Wyre for a period of five years (from 2024/25 to 2028/29).

To request acceptance of £30,000 of funding from the LCC Public Health Team to provide an active travel programme in Wyre for a period of one year (2024/25).

# 2. Council priorities

- **2.1** Provide support to those that need it, including our most vulnerable and financially disadvantaged residents and our ageing population.
- **2.2** Provide opportunities for people to lead healthy and active lifestyles.

#### 3. Recommendations

- That approval be given to accept the funding from the LCC Public Health Team of £372,735 for five years to provide healthy weight services for adults and children in Wyre and funding of £30,000 to provide an active travel programme in Wyre.
- 3.2 That approval is given to proceed with the engagement of YMCA Fylde Coast and Fleetwood Town Community Trust to provide the physical activity and the men's weight management elements of the adult weight management programme under the exemption to Contract Procedures contained within the Financial Regulations and Financial Procedure Rules

on the grounds that exceptions may apply where: "The services are of a specialised nature carried out by only one or a limited number of organisations which have local experience with no reasonably satisfactory alternatives available".

3.3 That approval is given to proceed with the engagement of Go Velo and Fleetwood Town Community Trust to provide the active travel programme under the exemption to Contract Procedures contained within the Financial Regulations and Financial Procedure Rules on the grounds that exceptions may apply where: "The services are of a specialised nature carried out by only one or a limited number of organisations which have local experience with no reasonably satisfactory alternatives available".

# 4. Background

- 4.1 The LCC Public Health Team have funded district councils through a service level agreement to provide healthy weight services since 2020/21. The adult weight management contract was tendered out to Slimming World and the Children's Weight Management contract to Healthy Heads. This four year contract is now coming to an end and LCC have decided to provide more resources over a longer period of time to district councils in the form of a collaboration agreement. This gives districts more flexibility to provide healthy weight services according to local needs. In Wyre, the funding for this new contract has increased from £50,000 per annum to £74,500 per annum (2024/25 to 2028/29) owing to the increased obesity and excess weight in the borough and the high levels of deprivation in certain wards.
- 4.2 The LCC Public Health Team also approached district councils to put in a bid proposal for £30,000 of funding to provide an active travel programme. Wyre's bid was approved in December 2023. This is a new programme of work for Wyre and will form part of implementation of the Wyre Moving More Strategy. This funding is from April 2024 for one year and is part of a Lancashire wide active travel scheme which is actively aiming to double the number of cycle trips, increase walking trips by 10% and reduce physical inactivity levels below the national standard by 2028. The active travel programme can also help reduce health statistics regarding heart and disease via increasing physical activity levels in all ages. There will be primary school learn to ride sessions, adult health cycles, a recycling bikes initiative, bike maintenance training, learn to ride sessions and more.

#### 5. Key issues and proposals

- **5.1** Approval is sought to commission healthy weight services as follows:
  - £200,000 Adult Healthy Weight contract for five years. This will go out to tender to specific providers in this market.
  - £100,000 Children's Healthy Weight contract for five years. This will go out to tender to specific providers in this market.
  - £20,000 Men's Weight Management contract for three years.
     Direct appointment of supplier Fleetwood Town FC Community Trust.
  - £20,000 Physical activity offer for people on the weight management programme for three years. Direct appointment of supplier – YMCA Fylde Coast.

- £32,735 Internal staffing to support the data inputting, provider meetings, promotion and marketing of the programmes.
- For the active travel programme, approval is sought to directly appoint Go Velo, (cycling training provider) and Fleetwood Town FC Community Trust to provide this programme in partnership with ourselves and Active Lancashire. All partners are involved in similar programmes already in Lancashire and delivery needs to commence as soon as possible.
- Once approved, we will enter into a collaboration agreement with LCC for five years for the delivery of the healthy weight services and a grant funding agreement with LCC for the delivery of the active travel programme.

# 6. Alternative options considered and rejected

6.1 We could look to deliver all of this provision ourselves but we do not have the resources and capacity to do this. It would be less cost effective and we wouldn't be able to support as many people to lose weight and/or become more active in Wyre if we didn't work in partnership as we propose.

Financial, Legal and Climate Change implications				
Finance	An additional £372,735 of revenue funding from the LCC Public Health team will be paid to Wyre Council over the next five years (2024/25 to 2028/29) to provide healthy weight services with an additional one-off payment of £30,000 in 2024/25 towards an active travel programme.			
Legal	A collaboration agreement would be signed with LCC for the healthy weight services and a service level agreement will be signed regarding the active travel programme.  Contracts with the suppliers for the provision of the services set out in the report will also be entered into.			
Climate Change	The active travel programme will support our climate change goals by encouraging more people in the borough to walk, cycle and wheel.
