The way in which a consultation on changes to a bus service were dealt with by a Town/Parish Council.	No code of conduct of conduct implications and substantive issue now resolved. Linked with complaint 2019/01 and the subject member in that complaint is no longer a councillor, not possible to take further action.
2029/03	A member of the public	A Parish/Town Councillor	That the subject member falsely give the impression in a radio interview that they represented a particular organisation.	Monitoring Officer has discussed with Independent Person. Concluded that issues raised did not meet initial tests. Complainant informed. No further action to be taken.
2019/04	A member of the public	A Wyre Councillor	That the subject member made abusive comments whilst delivering leaflets.	The subject member is no longer a Councillor. No further action to be taken. Complainant informed.
