I am writing to let you know of our concerns regarding the request for change of use of 76 Victoria Rd Cleveleys to be used as a Cashino 24 hours AGC, an application which is to be considered on 20th May 2020.

We are aware of this company as they also operate in Liverpool where we have an arcade. We feel that we must warn you that this kind of operation does not really fit in with the character of a smaller town like Cleveleys. Obviously as a seaside town, Cleveleys has a long tradition of amusements, we have operated there ourselves for around thirty years happily alongside competitors and other offerings which facilitate gambling and leisure activities. We believe our establishment offers an inclusive welcome and a sense of community, valued by our customers and not a site which peddles the "crack cocaine" of gambling, the high stakes machines and the 24 hours nature of gambling operations, a blight to Cleveleys society.

This company Cashino Gaming Ltd (part of an international group) operate 24 hours and often with just one member of staff in the shop. We are all aware that late night entertainments tend to attract anti-social behaviour which one member of staff is not in any position to deal with which means that the resources of the local constabulary are called upon.

Cleveleys is well served for AGCs, most of which are like our own, traditional and family run, there is no real need to add another such premises. But should this faceless and soulless organisation be allowed to operate, and it dents the modest profit of one of these family run firms and they were to disappear from Cleveleys high street, the area would be permanently the poorer for it.

This corporation have already showed their hand as a company which is driven only by profit in the timing of their application, they have used the current pandemic crisis when people are distracted. The shop keepers of Cleveleys are forced to stay closed, and whilst they may well have objections it is possible that they have not noticed what is going on in their neighbourhood.
